Fire Safety Seminar

On Wednesday June 9, Orsid Management arranged an hour-long Fire Safety Seminar by the NYCFD for 336 residents. A number of informative handouts were distributed to attendees and can be downloaded from the building web site.

Prevention and planning is the key to protecting your family and neighbors. Use this checklist as a guide to identify possible fire safety problems in your apartment. If you check NO to any question the potential hazard should be corrected to reduce your risk and increase your preparedness for fire. Immediately correct problems or hazards that are within your control or responsibility. Notify Sergio of any others that are not.

		1. Do you have at least one operable smoke alarm?
		2. Do you have at least one operable carbon monoxide alarm?
		3. Are all electrical cords in good condition? (not frayed or cracked)
		4. Are all electrical cords in the open, not run under rugs or through doorways?
		5. Is your apartment free from storage of flammable products such as gas or propane?
		6. Are space heaters placed at least three feet from combustibles?
		7. Are space heaters plugged directly into wall sockets and not into extension cords?
		8. Is your apartment door fireproof and self-closing?
		9. If you have a security gate, is it FDNY approved?
		10. Can many windows be opened easily from the inside?
		11. Are stairway fire doors fireproof and self-closing?
		12. Are stairway fire doors kept closed?
		13. Are exit lights in the stairway in good working order?
		14. Do you have operable flashlights handy?
		15. Do you have a fire escape plan?

Lorenzo "Chip" Scott, Jr

PRESIDENT'S POTPOURRI (CONT'D)

Despite the strains of a difficult economy, the stress of continuing price pressure and the on-going struggle with repairs large and small, our financial operations are running on a break-even pace, albeit with the benefit of a bit more than \$100,000 in transfer fees for the year. In that category, it is reasonable to anticipate we may have another similar amount of that unbudgeted revenue by year end. Our total cash on hand continues to hold at levels comparable to what we had last year. This is in spite of the repairs and maintenance work we have had to do in the past year or so. It also means that we are generally maintaining the reserves created when we refinanced the building three years ago.

There are three apartments for sale in the building (one is apparently close to contract), and another one has been taken off the market for the time being. It would appear the market in the building is reasonably healthy, if not completely robust.

The staff appears to be maintaining good discipline and excellent morale. Elias Ruiz has left us to move to Florida and follow a personal dream of more school and a different avocation. We wish him well. We expect to see some new faces through the summer as vacations occasion new temporary members. Sergio appears to have the schedule under control.

As our recent notice to the building indicated, we have called a special informational meeting of shareholders for July 14 (Bastille Day for history buffs). We feel it is necessary to share a progress report with everyone concerning the warranty work that is being performed to fix defects in the Local Law 11 work done from 2005 to 2007. The news is not entirely good in that we have discovered additional work that was not done – and most assuredly should have been – and which we cannot in good conscience do anything but complete this time. The incremental financial exposure for the building is considerable – as we will explain – although we are financially in a position to handle the incremental risk to which we are exposed. Please join us on the evening of July 14 for a full discussion.

I hope all enjoy the summer, the weather and especially a vacation break somewhere before the Labor Day weekend is too quickly upon us (and certainly before we get to the autumnal equinox).

A Message to the 93/94th Street Preservation Alliance

Dear Preservation Alliance Members,

To bring you up to date as best I can, it seems almost certain at this point that we will not be starting any of our planned rear-yard construction this summer. We simply have not been able to get the necessary permits in time to order construction materials, etc. We will probably being doing a few days of sample probes for future construction of the future covered area, but nothing much more than typical housekeeping—painting and minor repairs, etc. to the rears of the brownstones.

We are, however, beginning work on 30 W. 94th, almost entirely indoors. The demolition has begun, but as soon as that is completed all further work, save painting and repair of the facade and some yard work, will be carried out indoors—and should present no significant noise or construction issues. And lastly, we have cancelled the summer program that usually takes place for 6 weeks in the rear of the brownstones. All in all, it should be a relatively quiet summer.
